THIS RESOLUTION

BY THE BOARD OF SUPERVISORS of Washington Township, Franklin County, Pennsylvania.

WHEREAS, the Board of Supervisors of Washington Township, Franklin County, Pennsylvania for the purpose of alleviating health hazards in said township resulting from malfunction on-site sewage disposal systems, cesspools, and abandoned wells used as cesspools, authorize and empower the Washington Township Municipal Authority, (hereinafter referred to as "Authority") to undertake the design and implementation of a sanitary sewerage system for the Township; and

WHEREAS, to this end the Authority undertook the planning and implementation for said sanitary sewerage system for the Township and secured Sewage Permit #2873403 and Sewage Permit #2873404 bearing date of January 25, 1974 and January 30, 1974 respectively; and

WHEREAS, on May 16, 1974, the Authority was notified that it occupied the 147th place on the Priority List of Federal Construction Grant Projects, and

WHEREAS, following public hearing on June 21, 1974, the Authority was notified on August 21, 1974 that its priority rank had been changed by the Pennsylvania Department of Environmental Resources, (hereinafter referred to as the "Department") so as to place it in the 71st position on the Priority List of Federal Construction Grant Projects for the fiscal year 1975; and

WHEREAS, on February 3, 1975, the Authority was advised by the Department that it had been assigned the 87th position on the Priority List of Federal Construction Grant Projects for the fiscal year 1976; and

WHEREAS, public hearing on the aforementioned list is scheduled for Thursday, February 27, 1975 in Harrisburg, Pennsylvania; and

WHEREAS, the present position of the Authority on said Priority List

of Federal Construction Grant Projects for the fiscal year of 1976 may seriously jeopardize Federal Construction Grant Funding and the construction of a community sewerage system in said Township needed to alleviate the health hazards referred to above; and

WHEREAS, Federal Construction Grant Funding for said community sewerage system is necessary in order to make the installation of the same financially feasible; and

WHEREAS, it is the desire of the Board of Supervisors of Washington Township, Franklin County, Pennsylvania, to develop and implement said community sewerage system at the earliest possible time.

NOW THEREFORE, BE IT RESOLVED that the Board of Supervisors of Washington Township, Franklin County, Pennsylvania, hereby urges the Department to re-evaluate the Authority's project and postpone said Priority List of Federal Construction Grant Projects and advance the Authority's project upon said list to such a position as would enable the Authority to receive construction grant funding for the fiscal year 1976.

AND FURTHER BE IT RESOLVED that the Board of Supervisors of Washington Township support the efforts of the Authority in attempting to improve the Authority's position upon said Priority List by, inter alia, circulating petitions of support in the said Township and by the Authority Chairman's appearance at the Department hearing to be held on Thursday, February 27, 1975.
