A RESOLUTION #79

OF THE BOARD OF SUPERVISORS OF THIS TOWNSHIP ESTABLISHING
 A SCHEDULE OF FEES FOR THE ISSUANCE OF BUILDING PERMITS
 AND ZONING PERMITS

WHEREAS, Section 1904 of the Washington Township Zoning Ordinance provides for the establishment of a schedule of fees in connection with the issuance of building permits and zoning permits under said Ordinance; and

WHEREAS, it is the desire of the Supervisors of this Township to establish such a schedule of fees, superseding and replacing previous schedule of fees heretofore adopted by the Supervisors.

NOW THEREFORE, BE IT RESOLVED, as follows:

Section 1. The following fees shall be paid at the time of submission of an application for a building permit and zoning permit and shall be based upon the cost of all materials and labor required to complete construction of the improvement described in said application.

<u>Cost of Improvement</u>	<u>Fee</u>
\$ 500.00 or less	\$2.00
\$ 501.00 to \$1,000.00	\$ 4.00
\$1,001.00 to \$2,000.00	\$6.00
\$2,001.00 to \$30,000.00	\$6.00 plus \$2.00 for each \$1,000.00 of improvement over \$2,000.00
\$30,000.00 and over	\$62.00 plus \$1.00 for each \$1,000.00 of improvement over \$30,000.00
	MAXIMUM FEE \$300.00

Section 2. The fee for all zoning use permits shall be \$5.00 except as indicated below.

Section 3. Mobile home fees shall be as follows:

- a. Mobile home moved from one location in the township to another within the township.
 - A. Same owner Zoning permit and no charge
 - B. Change in Ownership Zoning permit with a \$5.00 charge

- b. Mobile home moved into the Township from another location in Franklin County.
 - A. Same owner Zoning permit with a \$5.00 charge
 - B. Change in ownership Zoning & Building Permit based on Cost value.

- c. Mobile home moved into township from another State outside Franklin County.
 - Zoning & Building Permit based on Cost value

- d. All mobile homes bought from a dealer and moved into the township will



require a Zoning and Building Permit based on value of the unit.

Section 4. The schedule of fees set forth in this Resolution shall take effect immediately.
